help anybody within the area with local issues etc and can be contacted by email david.fowles@cotswold.co.uk.


**Closure of Valley Bus Route 78**

Stagecoach who run the bus route in the Valley twice a week may stop this service in September 2023. Government money is received to run this service. Contact had been made by Virginia Stourton to Peter Stevens of Stagecoach approximately 1 week ago, but no reply has been received. The Bus route is a very important service for the community for people that cannot drive to get to Cirencester and social support. Cllr David Fowles offered to investigate this and will liaise with Virginia. NTD asked if the Parish Council could help in anyway, Virginia agreed she would report back to the Councillors with any development. It was suggested that Cllr Paul Hodgkinson should also be contacted about this.
